**Review of Minutes – October 18, 2019**

Chairperson Danny Creamer called the meeting to order. Mr. Johnathon Moore made a motion to approve the minutes as written and Mrs. Alexis Moore seconded his motion which was unanimously approved.

**Election of 2020 Officers**

Danny Creamer issued a call for nominations for 2020 officers.

After some discussion in the group, Alexis Moore made a motion for Maxine Creamer as Secretary and Danny Creamer as Chairperson for the 2020 year. Both accepted their nominations.
