Guide to Starting a New Business

Starting your own business is an exciting venture, but it can also feel overwhelming. This guide will help you navigate the key steps involved in getting your business up and running smoothly.

1. Registering Your Business

- a. Contact the Secretary of State www.scbos.gov to register your new business. Once your name is registered, you will be sent the Certificate of Existence.
- b. If operating as a limited partnership, prepare and file a Certificate of Limited Partnership with the Secretary of State. (Services of an attorney are recommended).
- c. Prepare and file with the Secretary of State the articles of incorporation with certificate indicating that publication of the notice of incorporation has been made and requisite advertising fees have been made (Services of an attorney are recommended).
- d. Complete the Secretary of State's annual registration. (Services of an attorney are recommended).

2. Apply for your EIN:

Obtain an Employer Identification Number (EIN) for tax purposes, even if you don't plan on hiring employees immediately. www.IRS.gov
Are you unsure if you need a FEIN? New Business | South Carolina Business One Stop (sc.gov) is a great resource for all new business questions.

- 3. <u>Licensing and Permits:</u> Various types of licenses, permits and registrations may be required to conduct business in South Carolina.
 - a. If the nature of your business requires a professional license or occupational license for operation contact the South Carolina Department of Labor and Licensing Regulation at www.llr.state.sc.us
 - b. If your business is specific to environmental, waste management/landfill, water treatment, underground storage tank, emergency medical service, healthcare, daycare, or food service concerns, contact SCDES (South Carolina Department of Environmental Services) for specific licensing and regulatory requirements at www.scdhec.gov.

- c. State Certifications for Women and Minorities. Visit their website to see if you can become certified www.govepp.state.sc.us/osmba
- d. Will my new business require a grease trap inspection? For questions Neal Klimek 803-739-5381

e. Will your business be located within the City of Cayce city limits?

Yes - You will need to complete a Zoning Permit Application. You can
do so in person or online www.caycesc.gov. For additional zoning

What to expect next? If you meet all required City of Cayce Zoning requirements, you will be contacted by city staff with instructions for your next steps. Including Building and Fire inspections.

Out of City Licenses (businesses completing a job in Cayce but are not domiciled in Cayce) can typically be issued the same day.

In-City businesses are required to renew their license every year **by April 30**. Out-of-City businesses are not required to renew until they start work inside the city limits.

4. Business Operations: There are many things to think about and consider when starting a new business. Business operations are all activities associated with running a business. Generating revenue efficiently and effectively is a vital part of owning and running a business. Things to consider:
