City of Cayce Special Council Meeting Wednesday, November 13, 2025

The November 13, 2025, Special Council Meeting was held this evening at 5:00 p.m. in Council Chambers. Those present included Mayor Elise Partin, Council Members Phil Carter, Byron Thomas, Tiffany Aull and Alice Rose. City Manager Michael Conley, Assistant City Manager Wesley Crosby, Municipal Clerk Mendy Corder, Finance Director Allison Barrs, IT Director Jamie Beckham, Utilities Director Betsy Catchings, Police Chief Bruce Wade, Fire Chief Steven Bullard and City Attorney Will Dillard were also in attendance.

Mayor Partin asked if members of the press and the public were duly notified of the meeting in accordance with the FOIA. Ms. Corder confirmed they were notified.

Call to Order

Mayor Partin called the Special Council meeting to order and Council Member Carter gave the invocation. Mayor Partin led the assembly in the Pledge of Allegiance.

Nomination and Election of Mayor Pro Tem

Council Member Thomas made a motion to nominate Council Member Carter as Mayor Pro Tem. Council Member Rose seconded the motion which was unanimously approved by roll call vote.

Approval of Minutes

Council Member Thomas made a motion to approve the October 7, 2025, Regular Council Meeting, October 13, 2025, Special Council Meeting, October 22, 2025, Regular Council Meeting and October 27, 2025, Special Council Meeting minutes as written. Council Member Rose seconded the motion which was unanimously approved by roll call vote.

Public Comment Regarding Items on the Agenda

There was no Public Comment.

Items for Discussion and Possible Approval

A. Discussion and Approval and Authorization for City Manager to Sign Financial Participation Agreement with SCDOT for Multiuse Trail off Foreman Street

Council Member Thomas made a motion to approve the terms and conditions of the financial participation agreement and authorize the City Manager to execute the agreement with the City's match of \$97,775.09 to be funded through the City's unrestricted reserve balance. Council Member Rose seconded the motion which was unanimously approved by roll call vote.

B. Consideration of Fireworks Exemption Request for Carolina Bonfire Event

Council Member Thomas made a motion to approve the fireworks exemption requested for the Carolina Bonfire Festival. Council Member Rose seconded the motion which was unanimously approved by roll call vote.

C. Discussion and Approval of Updated Contract with Samsara

Council Member Aull made a motion to postpone this item to the December 2, 2025, as City Manager Conley requested. Council Member Thomas seconded the motion which was unanimously approved by roll call vote.

D. Discussion and Approval of Memorandum of Agreements (MOA) with South Carolina Department of Transportation (SCDOT) for Utility Relocation (Water) for Frink Street Sidewalk Project

Council Member Rose made a motion to approve the contract utility relocation MOA for the Frink Street sidewalk project water line relocation and authorize the City Manager to execute the MOA. Council Member Thomas seconded the motion. He stated that he would like to see benches and trash cans there to keep things beautiful in that area. Mayor Partin called the question which was unanimously approved by roll call vote.

E. Discussion and Approval to move forward with the Hazard Mitigation Grant Program Application

Council Member Thomas made a motion to authorize the City Manager to sign the financial agreement commitment for the 25% required local match of the grant. Council Member Carter seconded the motion which was unanimously approved by roll call vote.

F. Update on the ColaJazz Invigorate Cayce Project funded through a Central Carolina Community Foundation Grant and Details of First Pop Up Concert Being Held November 23, 2025, at 2 Story Studios Located at 2018 State Street

City Manager Conley stated that the Cola Jazz Foundation, led by Mark Rapp, had been awarded a \$30,000 grant through the Central Carolina Community

Foundation for the Invigorate Cayce project. He stated that this initiative would revitalize three (3) underutilized spaces in Cayce through pop up jazz events that would combine clean-up efforts with live performances to create a vibrant community gathering. He stated that a 20% local match of \$6,000 was required and would be funded through the City's hospitality tax funds. He stated that the project supported the City's goals of enhancing visual appeal, foster community pride and encouraging investment in development while aligning with the Connected Communities grant mission to promote engagement and accessibility to the arts. He stated that the three (3) spaces that would be activated were 2 Story Studios at 2018 State Street, the City's Art Lot and Kelley Jones Park.

Ordinances

Council Member Thomas made a motion to approve the amendment to update the City's business license Ordinance on Second Reading. Mayor Pro Tem Carter seconded the motion which was unanimously approved by roll call vote.

B. Discussion and Approval of Ordinance 2025-09 Annexing Portion (1.86 Acres) of Property Located at or near 2490 Charleston Highway and 2121 Old Dunbar Road (Tax Map Number 006896-01-002) into the City Limits Under the Provisions of South Carolina Code Section 5-3-150 (3) – First Reading

Mayor Pro Tem Carter made a motion to approve the annexation and the zoning designation as it was consistent with the City's comprehensive plan. Council Member Thomas seconded the motion which was unanimously approved by roll call vote.

Mayor Pro Tem Carter made a motion to enter the committee approved minutes into the City's record. Council Member Aull seconded the motion which was unanimously approved by roll call vote.

Council Member Thomas made a motion to reappoint Ms. Donna Zeigler to the Public Safety Foundation. Council Member Rose seconded the motion which was unanimously approved by roll call vote.

C. Appointment of Council Members to City Boards and Foundations

Council Member Thomas made a motion to appoint Council Member Rose to the Beautification Foundation. Council Member Aull seconded the motion which was unanimously approved by roll call vote.

Council Member Rose made a motion to appoint Council Member Thomas to the Public Safety Foundation. Mayor Pro Tem Carter seconded the motion which was unanimously approved by roll call vote.

D. Appointment of Council Members to Designated External Boards and Commissions

Mayor Partin stated that an appointment for the Joint Municipal Water and Sewer Commission was needed since former Mayor Pro Tem Tim James sat on that board. City Attorney Dillard stated that it was his understanding that this board provided a per diem for the appointed members, thereby creating an economic interest so he recommended that whoever was nominated recuse themselves from the vote to avoid possible ethic violations.

Council Member Aull made a motion to appoint Mayor Partin to the Joint Municipal Water and Sewer Commission. Council Member Thomas seconded the motion. Mayor Partin recused herself from this item, the recusal form is attached.

Mayor Pro Tem Carter called the question which was unanimously approved by roll call vote.

Council Member Rose made a motion to appoint Council Member Aull as the alternate to the Joint Municipal Water and Sewer Commission. Council Member Thomas seconded the motion which was unanimously approved by roll call vote.

City Manager Conley stated that the City was a member of the National League of Cities which was an external organization and the City did not appoint a member to sit on the National League of Cities. He stated that each Council Members could be actively involved with the NLC and did not have to be appointed to it.

City Manager's Report

City Manager Conley stated that over 700 people attended the Tales on Trails event and he thanked Police and Fire staff and the Public Safety Foundation for hosting such a great event for the community. He stated that City offices would be closed from November 26 until Monday. December 1 for the Thanksgiving holiday. He stated that December 4 was the annual Tree Lighting and the Woman's Club of Cayce always did an outstanding job with that. He stated that the Carols Along the River would not be held this year due to the construction at the entrance to the Riverwalk. He stated that Saturday, December 6, from 6pm to 9pm was the Cayce Museum Traditions Olde and New Christmas event. He stated that they always did an amazing job as well. He stated that Saturday, December 20 the Cayce Public Safety Foundation, along with the Cayce Police Department, was holding Shop with a Cop, another amazing event that the Police Department and Public Safety Foundation Board puts on. City Manager Conley stated that Saturday, December 23 was the Greater Cayce West Columbia Chamber Holiday Parade of Lights which was a huge event that brought 20 to 25,000 people to the area.

Council Comments

Council Member Thomas stated that he, along with the City's banking partners, Synovus Bank, were holding a Free Money Smart workshop. He stated that he had partnered with the Center for Heirs to host another free will clinic at Mount Zion Church. He stated that the Cayce Action Group recently did an amazing job giving away over 100 turkeys to families in the community.

Mayor Partin welcomed Council Member Aull and Council Member Rose and stated that this was their official first business meeting. She thanked Council Member Thomas for having the great idea to separate out the swearing in from the business meeting.

Subject: Approval of New Samsara Contract for Vehicle Global Positioning (GPS) and Maintenance

Tracker

Issue

Council approval is needed to enter into a new 36-month agreement with Samsara to continue providing GPS/Maintenance Trackers and service to the City's fleet. This new contract reflects a revised scope and cost from the original agreement.

Discussion

Council originally approved the first Samsara contract in November 2022. That original agreement, like this new one, was for a **three-year (36-month) term**. The vehicle GPS and maintenance tracker devices plug into the vehicles diagnostic port and provide up-to-the-second location, speed, braking, harsh events, collisions, and maintenance issues, with all information stored in the cloud for staff research.

Differences from the Original Agreement:


The new contract reflects an expanded scope, increasing the number of core vehicle gateways from an estimated 115 to 135 and introducing 9 sets of dash cameras and associated live streaming licenses. The annual license unit price for the core equipment increased by 5.00%.

The Total Contract Value (including licenses, tax, and shipping) for the new 36-month agreement is **\$110,382.91.** The First Annual Payment for the new contract is \$36,794.30.

Funding for all subsequent years will be included in the respective annual budgets and split accordingly between the Utilities Fund and the General Fund.

Recommendation

Staff recommends that Council give approval for the City Manager to enter into an agreement with Samsara to provide vehicle trackers and software for the City fleet.

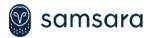



Visitors Center Site and Construction Request for Qualified Proposals (RFQ)

Issue

Council approval is needed to award the construction contract for the Cayce 12,000 Year History Park Visitor Center to Boyer Commercial Construction, Inc., the lowest responsive and responsible bidder.

Discussion

This request is for the formal award of the construction contract related to the **12,000 Year History Park Visitor Center**. The project procurement was handled in accordance with the City of Cayce's requirements.

Following a Request for Qualifications (RFQ) process, four (4) qualified firms submitted sealed bids for the project.

The bids received from the four qualified contractors were as follows:

•	Boyer Commercial Construction, Inc.	\$4,353,834	Lowest Bidder
•	Buchanan Construction Services	\$4,625,000	Second Lowest Bidder
•	Pyramid Contracting	\$4,649,545	Third Lowest Bidder
•	Harper General Contractors	\$4,914,000	Highest Bidder

Staff have reviewed the submissions and verified that **Boyer Commercial Construction**, **Inc.** is a qualified, responsive, and responsible bidder, meeting all project specifications and providing the necessary bid guarantee.

Recommendation

Staff recommends Council approve the award of the construction contract for the Cayce 12,000 Year History Park Visitor Center to Boyer Commercial Construction, Inc. in the base bid amount of \$4,353,834, and further recommends Council authorize the City Manager to enter into a construction contract agreement with Boyer Commercial Construction, Inc. Funding for this contract will come from previously allocated funds set aside in a special fund for the 12,000 Year History Park project.

Subject: Proposal Award for Advanced Water Treatment Study

Issue

Council approval is needed to accept American Engineering Consultants, Inc.'s proposal for the Water Treatment Plant's Advanced Water Treatment Study and to authorize the City Manager to execute the contract for this work.

Discussion

In March of 2024, Utilities staff prepared and submitted a Drinking Water State Revolving Fund (SRF) Project Questionnaire to request Principal Forgiveness funding to assist in evaluating treatment options to meet impending U.S. National Drinking Water Standards for Perfluoroalkyl and Polyfluoroalkyl Substances (PFAS). It is anticipated that the estimated cost to install and maintain treatment for PFAS will be a significant burden on the City (and all utilities). Given this situation, anything that can be done to minimize costs to customers is desirable. Decreasing out-of-pocket costs, even in the planning stage, will help to offset expenses and debt that will ultimately have to be passed on to customers. The City's Advanced Treatment Study Project was approved for funding under the Drinking Water State Revolving Fund (SRF) Emerging Contaminants Grant Intended Use Plan. In essence, Principal Forgiveness funding acts like a grant – it is a loan that does not have to be repaid.

The first step of the SRF process is to secure an engineering firm for the study. On June 2, 2025, the City released a request seeking proposals from qualified and experienced consulting firms to provide engineering services associated with the evaluation and testing of emerging contaminants at the City's Water Treatment Plant. This research and its findings will result in an engineering report that will provide guidance to the City on PFAS removal to meet the U.S. National Drinking Water Standards, which are currently scheduled to commence in 2029. The study will also evaluate treatment options for algal byproducts geosmin and 2-Methylisoborneol (MIB), which would minimize taste and order concerns during future algal blooms in the City's source water (the Congaree River). The Advanced Water Treatment Study will include bench scale testing and pilot testing to assist the City in developing a path forward for treatment of these emerging contaminants.

The deadline for engineering proposal submissions was August 1, 2025. Seven (7) submittals were received, reviewed, and scored by the Utilities Review Committee. The top scoring firm is American Engineering Consultants, Inc., which has partnered with Weston Solutions. Weston Solutions is an environmental firm with extensive experience in PFAS testing, monitoring, and regulatory compliance throughout the United States. Staff met with the consultant to discuss qualifications, project scope,

schedule, and cost. The proposed engineering fees are within budget. It is anticipated that the study will take approximately twelve (12) months to complete. Once the engineering contract is executed, the South Carolina Rural Infrastructure Authority will develop a Loan Assistant Agreement (LAA). The LAA will be brought to Council for approval at a later time, once available.

Recommendation

Staff recommends Council approve acceptance of the proposal from American Engineering Consultants, Inc. and authorize the City Manager to negotiate and execute a contract with the consultant. The cost for this project will be funded through a Drinking Water State Revolving Fund Principal Forgiveness Loan.

Issue

Council's approval is needed in order to ratify agreements approved by the City Manager, under the Emergency Powers of Sec. 2-146, with G.H Smith Construction, Inc. and Carolina Paving & Grading, LLC on 10/3/2025 for the emergency repair of a sewer main failure.

Discussion

The City of Cayce had to take immediate action in response to a sewer main failure on Lexington Avenue, located between State Street and First Street. G.H. Smith Construction, Inc. provided a quote and the necessary Certificates of Insurance for the needed repair work between State Street and First Street, and a price was agreed upon for the needed equipment, materials, and labor to complete this portion of the job. This portion of the project consisted of excavation in the asphalt roadway, installation of approximately 336 linear feet of pipe, reconnection of services, and placement of flowable fill in the trench. Carolina Paving & Grading, LLC provided a quote and the necessary Certificates of Insurance for the milling and repaving of the asphalt roadway in this same block of Lexington Avenue. A price was agreed upon for the needed equipment, materials, and labor to complete this portion of the job.

The total price quoted for the emergency repair work is as follows:

G.H. Smith Construction \$51,890.00 Carolina Paving & Grading, LLC \$32,513.00

The City Manager approved the quotes using the Emergency Powers established by City of Cayce ordinance.

Sec. 2-146. - Emergency powers.

In case of accidents or other circumstances creating an emergency, the city manager may, with the consent of the council, award contracts and make purchases for the purpose of repairing damages caused by such accidents or meeting such public emergency; but he shall file promptly with the council a certificate showing such emergency and necessity for such action, together with an itemized account of all expenditures.

(Code 1975, § 2-57)

Recommendation

Staff recommends Council ratify the City Manager's action executing agreements with G.H. Smith Construction, Inc. for \$51,890.00 and Carolina Paving & Grading, LLC for \$32,513.00. The total of \$84,403.00 in emergency contracts will be funded as follows: \$51,890 from the Utilities Wastewater Collection O&M budget for repair expenses and \$32,513.00 from the Utilities Wastewater Collection O&M budget for asphalt paving.

Issue

Council approval is needed for the Second Reading of an Ordinance to annex a portion of property located at or near 2490 Charleston Hwy and 2121 Old Dunbar Road (Tax Map Number 006897-01-002) and assign a C-4 Highway Commercial zoning designation.

Discussion

The applicant has requested the annexation of approximately 1.86 acre of land, located at or near 2490 Charleston Hwy and 2121 Old Dunbar Road (Tax Map Number 006897-01-002), and its rezoning to a C-4 Highway Commercial designation. The annexation includes .022 acres recently purchased from GS Mini-Mart and 1.84 acres from Palmetto State Armory. Currently both recently acquired portions of property are unincorporated.

The purpose of the annexation is to help expand the existing Carolina Power property at 2490 Charleston Hwy. Bringing this part of the property into the City limits will make it easier to manage everything under one government, improving coordination and making it simpler to follow the rules.

The City's Future Land Use Map shows that the property is planned for Commercial-Business/Retail (CBR), which includes office, retail, and service businesses. The annexation and zoning request fit with the City's overall plan and goals for land use.



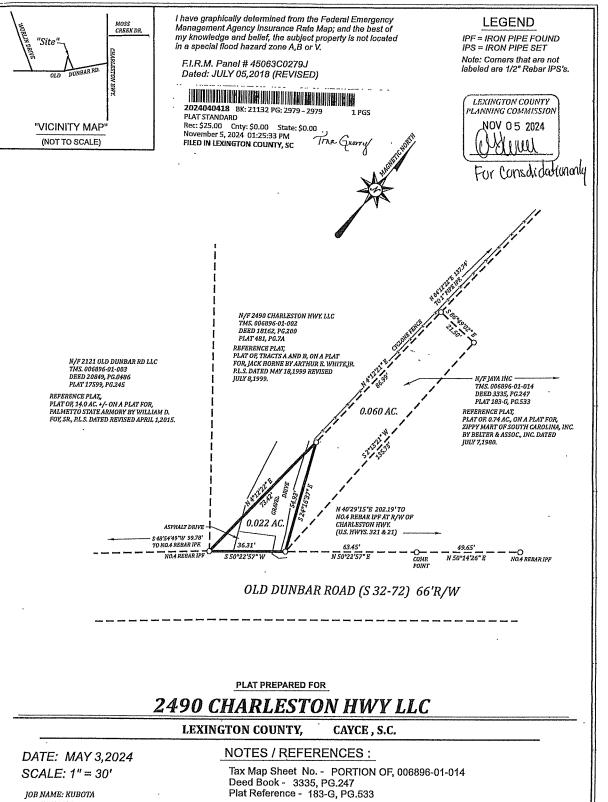
