Position Summary

The primary purpose of this class is to provide skilled monitoring of food establishments that produce fats, oils, and greases (FOG) that discharge wastewater to the City wastewater facility. The class works within a general outline of work to be performed and develops work methods and sequences under general supervision.

Position Responsibilities- Essential

This list of tasks is illustrative ONLY and is not a comprehensive listing of all functions and tasks performed by positions in this class. It does not imply that all positions within the class perform all of the duties listed, nor does it necessarily list all possible duties that may be assigned.

- The tasks listed below are those that represent most of the time spent working in this class. Management may assign additional tasks related to the type of work of the class as necessary.
- Inspects Grease Removal devices (GRD) and troubleshoots malfunctioning devices.
- Inspects food service establishment kitchen and food facilities.
- Coordinates and corresponds between food service establishment manager and City authorities.
- Conducts annual inspection correspondence and additional needed mail correspondence.
- Reviews new construction GRD.
- Conducts site visits of new or remodeled kitchens GRD.
- Maintains the FOG Database.
- Assists with the Industrial Database.
- Assists in industrial inspections.
- Arranges sampling of GRD's.
- Performs FOG office and related housekeeping duties.
- Performs work safely and adheres to all safety regulations.

Other duties as assigned

Essential Skills and Experience

- Requires any equivalent combination of training and experience which provides the required knowledge, skills, abilities and certification. FOG inspection experience is preferred.
- Must possess a valid South Carolina driver's license
- Prefer any Class Biological Wastewater Treatment Plant Operator's Certification or FOG Inspection experience equivalent to this Certification.
- Requires high school diploma or GED and vocational/technical training in water/wastewater treatment or related field; Special courses or self-education that is equivalent to satisfactory completion of one year of college education or specialized advanced training.



Beneficial Skills and Experience

Requires being responsible to guide others, requiring frequent decisions, affecting the individual, co-workers, and others in the general public; works in a somewhat fluid environment with rules and procedures but many variations from the routine.
