

## INVITATION TO BID

**RECEIPT OF PROPOSALS:** The City of Cayce will receive bids for the Six Mile Creek Sewer Interceptor Phase 1 Rehabilitation project until **2:00 PM, Thursday, October 3, 2024**, at Council Chambers, located at Cayce City Hall, 1800 12<sup>th</sup> Street, Cayce, South Carolina 29033 at which time all bids will be publicly opened and read aloud.

**PROJECT:** The project is for the installation of Cured-In-Place Pipe (CIPP) lining of approximately 1,200 feet of existing 30-inch sewer and 1375 feet of 36" gravity sewer, located in two cross-country sections behind Moss Creek Drive Neighborhood and Old Dunbar Road Neighborhood, and the manhole rehabilitation of 18 manholes of various sizes and depths.

Bid Documents may be obtained from City of Cayce Utilities, Cayce City Hall, 1800 12<sup>th</sup> Street, Cayce, SC 29033 upon a non-refundable payment of \$75.00 for each set of documents. Checks shall be made payable to City of Cayce.

**BID SECURITY:** A satisfactory Bid Bond executed by the bidder and acceptable sureties in an amount equal to five percent (5%) of the amount of the Bid shall be submitted with each Bid.

**OWNER'S RIGHT RESERVED:** No Bid shall be considered unless the bidder is legally qualified under the provisions of the South Carolina Contractor's Licensing Law and has the appropriate classification for the work that is to be conducted.

Withdrawal of Bids due to error shall be subject to and in accordance with Section 11-35-1520 of the South Carolina Code of Laws and the Contract Documents. No Bidder may withdraw his bid within 90 consecutive days after the actual date of opening without consent of the City of Cayce. The City of Cayce reserves the right to waive any informalities in the bidding or to reject any or all bids. Bids may be held by the City of Cayce for a period of ninety (90) days from date of the opening of bids for the purpose of reviewing the bids and investigating the qualifications of Bidders, prior to award of the Contract.

The City of Cayce does not discriminate in the solicitation or awarding of contracts on the basis of race, religion, faith-based organizations, color, national origin, age disability or any other basis prohibited by state or federal law.
