By submission of this BID, each BIDDER certifies, and in the case of a joint BID each party thereto certifies as to its own organization, that this BID has been arrived at independently, without consultation, communication, or agreement as to any matter relating to this BID with any other BIDDER or with any competitor.

BIDDER hereby agrees to commence WORK under this CONTRACT on or within seven (7) days of a date to be specified in the NOTICE TO PROCEED. The BIDDER agrees to accomplish all items shown on the plans and described in the specifications. The BIDDER agrees to substantially complete the project within ninety (90) days after the date on the notice to proceed (but completion must be no later than October 1, 2020) as described in paragraph 1C.10 in the Special Conditions and BIDDER agrees to pay as liquidated damages the sum of \$100.00 for each calendar day thereafter in which the project is not substantially complete.
